# FILLING OF A BOARD VACANCY CREATED BY THE RESIGNATION OF MS. EVELYN CAFFERTY, (ISME Nominee)

Following Evelyn Cafferty's resignation on 1<sup>st</sup> April 2017 and a request made to ISME for her replacement a reply was received on 17<sup>th</sup> September, 2018 with correspondence ISME sent to Minister Bruton stating:-

We will withhold nominations from ISME to fill any other vacancies in the ETBs until the completion of a comprehensive review of corporate governance practices and procurement practices throughout the ETB network".

The Board decided on the proposal of Mr. M. Molloy and seconded by Ms. M. Bohan to proceed to request a replacement nominee from the Bodies representative of Business, Industry and Employeers Bodies specified by the Minister in accordance with Section 30 (11) (a) of the Education and Training Boards Act 2013 and write to Chambers Ireland and Irish Business and Employers' Confederation (IBEC) to participate in the filling of this vacancy.

Completed Application Forms to be returned by post to the National President ETBsNPA by 5<sup>th</sup> October, 2018.

#### FINANCIAL REPORT.

Mr. T. Grady presented the combined Financial Report for Mayo, Sligo and Leitrim Education and Training Board and circulated details of the Receipts and Payments to the end of August, 2018. Total expenditure amounted to €53,627,000 with total receipts of €52,063,000. Total expenditure on the Capital Account amounted to €369,000, with total receipts of €362,000. The Bank Balance at the end of August 2018 was €7,469,257.

# FURTHER EDUCATION AND TRAINING REPORT.

Mr. Peter Egan, Director of FET, presented the Further Education and Training Report for Mayo, Sligo and Leitrim Education and Training Board – Appendix 5.

Mr. Peter Egan informed the Board Members that MSLETB have just been informed that the Draft Butchery Apprenticeship has been validated by QQI. We hope to commence delivery by November. It is an important milestone, as one of Ireland's oldest professions has rightly got its proper place as a statutory apprenticeship.

The Commis Chef apprenticeship programme was the first new apprentice programme validated in June 2017.

Development of the Associate Sales Professional Apprenticeship has commenced.

MSLETB are leaders in terms of apprenticeships nationally. It is proposed to conduct a sectoral Ministerial launch of the 3 new apprenticeship programmes, to showcase the sector and launch the 3 new apprenticeship programmes together. Board members congratulated Mr. P. Egan.

MSLETB received confirmation from DES sanctioning the Youthreach Centre for Leitrim. Members thanked Mr. P. Howley for his work and commitment in establishing a Youthreach Centre in Mohill, Co. Leitrim and congratulated Mr. P. Egan on the new FET Centre in Carrick on Shannon. Mr. John Caulfield advocated the value of apprenticeships and reflected on the need for training sessions to change parents attitude on the value of apprenticeships.

Home Gardens Prize Scheme: To approve the award of €540 in total under the Home Gardens Prize Scheme 2017 / 2018 School Year – Mayo Area to students in St. Tiernan's College, Crossmolina, who participated in the 2017/2018 Home Gardens Prize Scheme for the best kept and cultivated Home Garden Plots as per the terms and conditions of the Award Scheme. On the proposal of Ms. T. McGuire and seconded by Ms. T. Whelan.

ETBI New patron of primary school - Louth and Meath ETB 20/07/2018: Louth and Meath ETB has been confirmed by the DES as patron of a primary school in Faughart, Co.Louth. This school had been under the patronage of the Archbishop of Armagh and will reopen as a Community National School in 2018. This is a significant development for the sector. The inclusive ethos of the CNS model along with the education and governance supports available to them through ETBs is proving to be an attractive model to communities right across the country. LMETB issued a Press Release "The Chairperson, Chief Executive and Members of Louth and Meath Education and Training Board warmly welcome the announcement by the Minister for Education and Skills confirming Louth and Meath education and Training Board as Patron of Scoil Náisúnta Bhrigdhe, Faughart, Co. Louth". Press Release included Announcement from Minister Bruton re Multi-demominational School for Faughart, Co. Louth etc.

Press Release KWETB 26.07.2018: New Community National School for Brannoxtown, Co. Kildare: "The Chief Executive of Kildare and Wicklow ETB Dr. Deirdre Keyes welcomes the Minister of Education and Skills announcement that a new multi-denominational, Community National School (CNS) is to open in Brannoxtown, Co. Kildate. Etc." ETBI are pleased to advise of yet more exciting news for our sector and for community national schools specifically. The General Secretary, Nessa White states that the growth and further development of the CNS model is one of our key priorities for 2018/19 and the support and collaboration provided by ETBI to date will continue to be available to ETBs considering being involved in competing for new schools or as part of the reconfiguration proves.

Schools Reconfiguration: DES Identification Phase Report Sections 1-7 on Claremorris issued to Board Members for information purposes. This reports from MSLETB to the Department of Education and Skills outlines the level of demand for diversity within the Claremorris area and the response of the Archbishop of Tuam as to how this might be accommodated. The Report is subject to the Official Languages Act and will be submitted in both languages to the Department of Education and Skills. The Report will be published on the Department's website, with quarterly reports on implementation.

The investigation was to consider the performance by the Board of its functions particularly, in relation to public procurement, usage and disposal of assets and propriety and other matters, to submit a Draft report to the Board and Final report to the Minister as soon as was practicable. The CE informed the Board that a new Code of Governance (drafted) will strengthen governance requirements and will involve further training levels at Board and Admin.

#### **HUMAN RESOURCES REPORT**

Recruitment: High levels of activity from May – September 2018, particularly in the area of Teacher recruitment. 134 positions advertised across 13 advertisements, 78 appointments made to date. Non-teaching Recruitment: 40 positions advertised since May 2018, 26 appointments made to date. High levels of recruitment to continue for the remainder of 2018 due to a number of factors: DES sanction of a number of key administrative posts as well as any consequential backfills arising. A number of key FET positions recently sanctioned by SOLAS The impact of CL 0003/2018 which will allow for the appointment of approx. 44 Posts of Responsibility in our post primary schools.

Issuing of Employment Contracts for all new recruits across the scheme ongoing.

#### DCS:

New ICT System (DCS) which enables all part time salary claims to be processed electronically is live since September 2018. Training for key personnel involved from Schools, Finance and HR is ongoing. Mayo and Leitrim schools are now actively using DCS. Training for Sligo schools and key HR and Finance personnel in Sligo to take place in October. The next wave of training will involve Further Education and Training personnel.

Interview Board training took place in May 2018.

A number of distinct pension projects ongoing in the Pensions Department in Sligo.

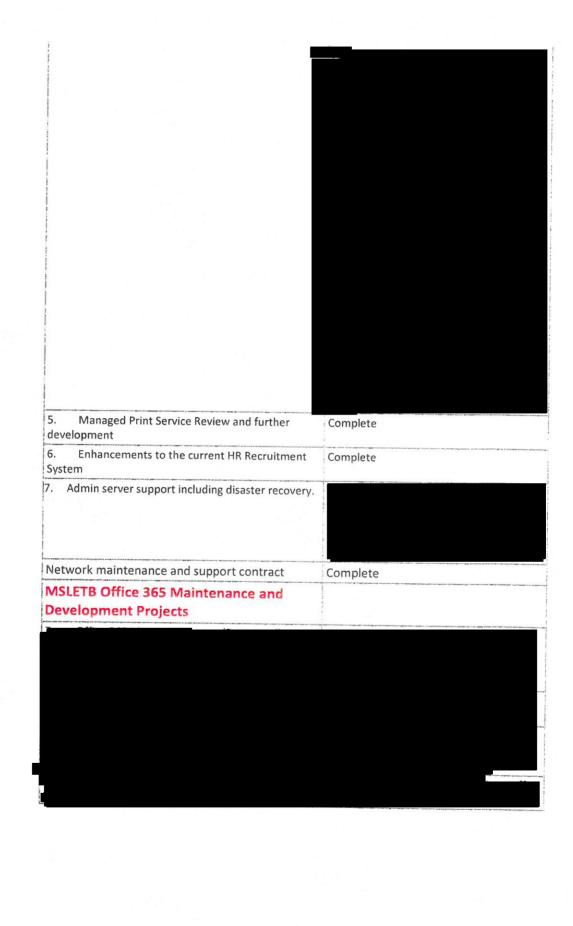
Annual induction training for new appointees to teaching to take place in the coming weeks.

#### **Finance**

- 2016 Financial Statements were certified by the C&AG on 31 July 2018. Qualified audit opinion – weaknesses in the Board's accounting system resulted in delays in the production of the accounts together with errors in the draft accounts presented for audit.
- Management Letter for 2013/14/15 was received from C&AG, draft management responses prepared and submitted to C&AG.
- The C&AG audit fieldwork of the 2017 draft accounts of MSLETB commenced on 20 August and ended on 21 September. The target to have these accounts certified is by 31 December 2018.
- The Way2Pay on line system for receipting of monies into schools commenced operations from 1 September. This will ensure monies are received directly into the main ETB bank account, reduce administration in the schools and improve the collection rate.
- The Payroll Shared Services project for all ETB's has now moved to the collection of information on how MSLETB's current payroll processes operate. The transfer to Shared Services for MSLETB is expected in early 2020. Significant internal "readiness" work has to take place in advance of this date.

# Update on IT Projects September 2018 **MSLETB Administration Projects** September 2018 Update Administration Network Upgrade (Admin All works now complete Offices and Training Centres) MSLETB has 5 administrative sites, all the administrative sites are connected via Government Networks (GN) and they share services over this network. Both the GN network switches and the MSLETB network switches at each site are critical for the provision of services to MSLETB. The network was originally setup as independent sites with individual GN connections at each site. The MSLETB network switches at each site now need replacing and a reconfiguration of the topology is required. In order to prepare for shared services, enhance network security and to guarantee the provision and continuity of service to all the admin sites, it is recommended that the following project is implemented asap. Administration Offices Data (Files and Folders) Files and folders from 3 Admin consolidation and preparation for GDPR Offices have been copied to Cloud Storage. Cloud Storage in Sharepoint has been configured for Human Resource Department and process of merging local files from our 3 Admin Offices to this cloud space is commencing this week (September 24th) When complete Files and folders from other Departments will be processed in the same way. When complete by the end of October all admin office staff will have access to their files and folders in one location. # Schools ICT Developments 2018

12. Use the new ICT grant (2018) to support the Digital Strategy for Schools including further upgrades to School Networks and moving data and services to the cloud.

During the summer all school PCs have been upgraded to Win 10 (1803) Over 2000 devices were imaged by IT staff including 300 new PCs and 180 laptops. 7 schools have moved from dependence on a local server to Azure cloud services for their computer rooms and this will continue over the year.

Every PC at every location is now setup with a standard Win 10 Operating system which will improve security and performance, make support and maintenance easier, and streamline CPD provision.

DCG rooms in Azure schools will be reviewed and a suitable local storage solution will be installed where required.

14. Consultation with each school on their ICT Infrastructure requirement in February March.

Following consultation and an ICT survey completed by all schools all teacher Desktops or Laptops (Classroom devices) were upgraded from Schools ICT Grant. Individual schools have continued to upgrade their computer rooms also from the grant. All schools identified the poor state of their classroom projectors and the lack of WIFI as major concern for the effective delivery of the Digital content of the New Junior Cycle. These areas will need to be addressed as soon as possible

In some schools , the admin offices still have to be migrated to Windows 10 and this work in ongoing during regular scheduled Technician support days .

# Further Education and Training Report – MSLETB BOM Meeting, September 2018

#### NOTES, ITEMS OF INTEREST

- In early May MSLETB submitted 3 year Draft Targets and Strategic Performance Agreements. On 28<sup>th</sup> May MSLETB CE and FET Leadership team met **SOLAS** to agree MSLETB performance agreement. The submission and process was peer reviewed by external panel members and SOLAS will forward the note and actions emanating. MSLETB has submitted the Strategic Performance Agreement on the 20<sup>th</sup> september. **SOLAS** has agreed MSLETB FET budget of €31,850,000. This is a significant increase of approx. €1,400,000 on our initial allocation based on additional activity in new apprenticeship, traineeship, refugee and the new Youthreach for Leitrim. 8 Goals have been agreed:
  - o Increase 10% Placement; Increase 10% Progression: Increase 10% in certification transversal skills; Increase 10% in Adults in Lifelong Learning; Increase nationally 10,000 Learners in Lifelong learning; Increase T/Ships/ Apps; FET Literacy & Numeracy Strategy; 10% increase in stakeholder satisfaction.
- FET Human Resources –New posts, 3 AEO's, FET Admin Grade 5, New apprenticeship 6 posts, 2 new AEGS for Mayo, Recruitment Officer Training Mayo, ICT Regional Co-ordinator.
- Youthreach Leitrim Coordinator and Teacher appointed, planning phased start up. Learners will be enrolled December 2018.
- New Generation Apprenticeships. Final stages of validating the Butchery Apprenticeship with QQI; we have commenced
  development of the Associate Sales Professional Apprenticeship and are planning to deliver the new Commis Chef and ICT
  apprenticeships in last Qtr. We continue to collaborate on all new apprenticeships that come on stream.
- FET Cluster meetings at a county level to discuss provision and other continuous improvement ideas are scheduled, 1st meeting in Leitrim in May.
- Significant work has commenced in the development of harmonised QA Policies and Procedures and we are working towards implementing a Quality Management System and Framework to improve planning, delivery, review and monitoring. As part of the re-engagement process with QQI we have completed an Executive Self Evaluation and Quality Improvement Plan.
- MSLETB is the lead ETB in the piloting of development of new FET awards under the revised Core Policies and Criteria for the Validation by QQI of Programmes of Education and Training (2016). The pilot programme(s) being developed is Agriculture (WCFE). Our participation in the pilot will aid our capacity to participate in the development of new programmes. This new policy fundamentally changes the way programmes are developed, designed and how the syllabus/curriculum will be managed and continuously updated.
- CPD. In 2018, to increase the incidences of CPD, we have commence the piloting of key CPD programmes for FET staff. 2 pilot TEL programmes are currently underway. 2 New national pilots in Change Management and TEL;
- Employer Engagement. Momentum is growing and the twin imperatives requiring us to contribute to national polices and targets and engage with employers in Mayo, Sligo & Leitrim to support workforce development to ensure that our programmes support existing and future labour market needs compel us deepen and widen our engagement with employers. The EE Working Group have developed a EE Tool to support and record our engagements with employers, the EE Tool will go fully live in last Qtr.
- National Programme Review's. The PLC review has been completed and we will be engaging with SOLAS to implement the
  recommendations emanating from the review. Currently a national Youthreach review is underway.
- PLSS and FARR (Learner Database and Management Information System on FET performance) We continue to implement.
- Continuing to progress Technology Enhanced Learning across FET in infrastructure, equipment, CPD and we have recently commenced a pilot programme to develop blended learning across all FET provision
- Buildings: approx.. 470€K in capital allocated for FET buildings in 2018. Works commenced- Carrick-on-Shannon FET Centre,
   Swinford Sligo TC, Incremental works in Achill, Ballycastle, Sligo & Ballina TC etc.
