APPROVAL OF 2020 FINANCIAL STATEMENTS INCLUDING STATEMENT ON INTERNAL CONTROLS

Mr. J. McGoey, A.P.O Finance briefed the board on MSLETB's 2020 financial statements which includes a statement on internal controls. The Statement on Internal Controls was reviewed and discussed in detail by the Audit and Risk Committee at their meeting on 12th March 2021 and was recommended for approval by the Board. Human Resources was nominated by the CE to act as an independent observer. Chairperson, Cllr. J. Announcement re Mayo College of Further Education

The CE advised the Board that Mayo, Sligo and Leitrim Education and Training Board has today announced the founding of a new Further Education and Training college: Mayo College of Further Education and Training. Building upon the productive and mutually cooperative working relationship of Castlebar College of Further Education (CCFE) and Westport College of Further Education (Westport CFE), this new college will bring together both entities in a major evolution of further education and training for the region.

The CE advised that the new College will be a vibrant, diverse and inclusive college hosting a wide range of Further Education and Training opportunities at Level 5 and Level 6 on the National Framework of Qualifications. The fusion of Castlebar CFE and Westport CFE is a significant milestone in the development of Further Education within Mayo Sligo and Leitrim ETB. Mayo College of Further Education and Training will be the new home to 450 fulltime and 500 part-time students across the two campuses in Castlebar and Westport".
