#### **ADOPTION OF MINUTES**

#### **RISK MANAGEMENT**

The DOSD updated the Board on improvements made to the Risk Register and invited the DOS to present on the Schools Risk Register with details of improvements made and continued monitoring of Health and Safety in MSLETB Schools. The DOS updated the Board on nine school risks categories on the Schools Risk Register including Cybersecurity, Data protection, Safety Health and Wellbeing, Student Safety/ Child Safeguarding, Service Provision/Business Continuity, Statutory Inspections, Excellent teaching learning & training, Service Provision/structural, Protection of students, staff, visitors & premises from Fire. The Chairperson Cllr. M. Bohan and the CE thanked the DOS for her work on the Schools Risk Register.

#### **MSLETB STRATEGY STATEMENT**

The CE sought approval from the Board for the final version of the Strategy Statement 2023 - 2027. The Board approved the Strategy Statement 2023-2027 on the proposal of Cllr. R. Finn and was seconded by Cllr. E. Stenson.

The CE acknowledged and thanked the Board for their valuable participation in the process, the Strategy Statement is an important high-level document for the organisation. The CE also thanked Mr. Peter Ryan, RA Consulting who assisted in the consultative process and worked alongside the EMT. The CE thanked all involved in preparing the Strategy Statement and in particular the following staff in Corporate Services, Ms. O. Reilly, Ms. J. Kelly, Ms. C. Leonard, Ms. A. Daly and Ms. F. Foody.

### APPROVAL SOUGHT FOR THE RENEWAL OF ELECTRONIC FUNDS TRANSMISSION FACILITY

Mr. J. McGoey, Finance Officer briefed Board members on the rational of having the EFT in place. The Board recommended the renewal of the Electronic Funds Transmission (EFT) facility for 2023 on the proposal of Mr. Pat Forde and was seconded by Cllr. Sean Carey.

Rent: € 250.00 per annum

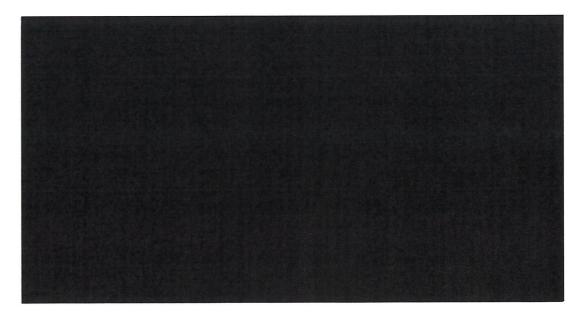
The Board approved the lease for Kinlough Childcare Limited on the proposal of Cllr. C. Hyland and was seconded by Cllr. E. Stenson.
