
The CE welcomed Mr. John Moran who is the new Parent Representative and wished him well in his new role. The CE noted that the position of female representative is still open.

EVENTS

Mr. Colm McEvoy, Chief Executive of **Kerry ETB** and Mr. Owen O'Donnell visited MSLETB, Quay Street and the Training Centre in Sligo on the 26th August. This should present positive opportunities to collaborate in the future.

The CE advised the Board that he attended the **OECD Local Development Forum** in Cork 14^{th} – 17^{th} June 2022.

Minister Heather Humphreys opened the Market Yard premises on Carrick-on- Shannon on the 20th July 2022.

The CE advised the Board that the Graduation Ceremony for Craft Butchery took place on 20th July in Teagasc, Ashtown, Dublin. This was a very successful event and the CE congratulated all the apprentices.

The CE noted that the **World Skills Ireland Live event** took place in the RDS, Dublin on the 13th, 14th and 15th September. This was a very successful event and MSLETB were very well represented.

The CE extended his congratulations to all those involved. About two thirds of our schools attended with support from MSLETB FET.

Minister Norma Foley officially opened the additional school building in St. Tiernan's College Crossmolina and also visited Davitt's College in Castlebar on the 15th September. Both very successful and positive events and well attended by the community and local dignitaries. The CE thanked all those who made this event so successful.

The CE attended the ETBI CE Forum on the 8th June and on 14th September 2022.

The CE noted that the Organisation Design for Phase 2 was a key item presently with the CE Forum.

The CE advised the Board that he is a member of the National Apprenticeship Alliance. MSLETB have 2 new apprenticeships programmes approved at Level 6 and are the coordinating provider for:

- 1. Digital Marketing and Media
- 2. Immersive Technology

The CE briefed the Board regarding attendance at the Principals meeting on the 19^{th} September and will be attending the Deputy Principals meeting on the 23^{rd} September for the start of the school year.

The CE advised the Board that MSLETB have 3 new Deputy Principals this year and the CE and DOS met the three Deputy Principals last week for support with this transition.

The CE advised the Board that a number of teachers have requested **permission to travel abroad** and these are available for noting on One Note.

The topic of **School Completion Programme** was raised. The CE expressed some concern around the governance of the program to the Board but indicated that ETBI is endeavouring to engage with the Department regarding the programme. The Board of MSLETB are of the view that the programme should either be fully delivered under the remit of the ETB or fully allocated to some other entity. It was agreed that a letter would be sent to the Department of Education from the Board to urge the Department to engage with the stakeholders involved in this very beneficial programme to address the concerns that are being raised through ETBI.

SCHOOLS REPORT

Ms. Mary Madden, Director of Schools (DOS) presented a comprehensive report on Schools for the Mayo, Sligo and Leitrim Education and Training Board. The DOS congratulated all students who recently did their Leaving Certificate. The DOS advised the Board that three new Deputy Principals will be starting this year and a full days induction will be provided by MSLETB.

The DOS informed the Board that there are a number of vacancies on the schools Board of Management Committees and that a sub-group of the Board will be meeting to fill these positions. The DOS informed the Board that the schools report is available to view in full on One Note.

Cllr. M. Bohan acknowledged the hard work that is ongoing by the Director of Schools.
