ADOPTION OF MINUTES

The CE thanked the Board and all staff in MSLETB who gave input or worked on the Strategy Statement and acknowledged Ms. June Kelly, Corporate Services and Ms. Shannon Cassells, Communications Officer for their work on the Strategy Statement.

The Chairperson Cllr. M. Bohan welcomed Ms. Ann Marie McDaniel, Parent Representative to her first Board meeting.

APPROVAL OF LEASE AGREEMENT

The CE sought approval from the Board for a site at Swinford Further Education Centre.

The Board approved the Site at Swinford Further Education Centre, Co. Mayo on the proposal of Cllr. D. Sheridan and was seconded by Mr. P. Coffey.

APPROVAL OF 2022 FINANCIAL STATEMENTS INCLUDING STATEMENT ON INTERNAL CONTROLS

Mr. J. McGoey, A.P.O Finance briefed the Board on MSLETB's 2022 Draft Financial Statements which includes a Draft Statement on Internal Controls. The Draft Statement on Internal Controls was reviewed and discussed in detail by the Audit and Risk Committee at their meeting on 22nd March 2023 and was recommended for approval by the Board. The Head of Finance acknowledged it was a cross functional team effort and it was more challenging this year as there were three financial reporting systems in operation during the year.

The 2022 Financial Statements including the Statement on Internal Controls were adopted on the proposal of Cllr. P. O.Rourke and was seconded by Mr. M. Molloy.

The Letter of Representation was adopted on the proposal Mr. M. Molloy and was seconded by Mr. S. Kilgannon.

The CE thanked Mr. J. McGoey, APO Finance and Mr. P. Howley, DOSD for their great work along with their team in completing the 2022 Financial statements.


GOVERNANCE/REPORT FROM SUB- COMMITTEE's
