On the 17<sup>th</sup> of June 2024, the Board approved an extension of 15 years to the Lease at the Benwiskin Centre up to 21st of November 2039. The extension was required by the Centre to allow them to apply for CLÁR funding.

On receipt of Board approval, MLSETB sought legal advice regarding the type of Agreement to be executed and applied for Departmental approval. The Department sought a current Building Energy Rating certificate. MSLETB have since secured the Legal Advice and BER Certificate, but the Department have not yet approved the application.

MSLETB require the Board to minute the approval for the 15-year extension to commence on receipt of approval from the Department.

The Board approved extension of Lease Agreement at Benwiskin Centre, Ballintrillick, Co Sligo. from 21<sup>st</sup> of November 2039 to 15 years from the date of approval from the Department on the proposal of Cllr. James Gilmartin and was seconded by Mr. Aidan Brogan.
